Terms and Conditions for Students

General

This document sets out the terms and conditions ("**Terms**") on which you may make use of EU4EU PORTAL (the "**Portal**") in order to apply as student ("**you**" or "**Student**") in accordance with the "[CALL FOR STUDENTS](#)" (the "**Call for Students**") for the project of mobility for traineeship for higher education students - financed by Erasmus+ KA131" (the "**Project**").

Please read these Terms and the Call for Students carefully before you start to use the **Portal** and to make the application as Student for the Call for Students. By using the **Portal** and applying as a Student, you indicate that you accept these Terms and the terms of the Call for Students and that you agree to abide by them. If you do not agree to these Terms and to the terms of the Call for Students, please do not use our **Portal** and do not apply as a Student.

Information about us

The **Portal** is operated by EuGen - European Generation, with offices in Via guerrieri 3, 00153, Rome, Italy; email address: info@eu-gen.org ("**we**", "**our**" or "**us**"), which acts as intermediary organization of the project of mobility for traineeship for higher education students.

Application as Students

To apply as a Student, you are requested to register on the proper area of the **Portal** and to follow the relevant instructions by filing in proper forms and uploading required documents, including the Letter of Availability from the Host Organization.



You acknowledge and agree that your application as a Student does not ensure and guarantee your participation in the Project. Indeed, after your application, your requirements for the eligibility will be verified as Student for the Project as set out in the Call for Students and the outcome of the investigation and your participation to or exclusion from the Project will be notified to you. During the investigation, EuGen is entitled to ask for clarifications and additional documentation if it deems it appropriate at its own discretion.

EuGen membership

By making the application as student you expressly:

- request a free subscription to EuGen;
- declares to know and accept the aims and the statute of the association;
- you undertake to comply with the statute, regulations and resolutions of the corporate bodies.

By becoming an EuGen member, in addition to participating in the EU4EU project, you will have access to possible discounts and facilities reserved for members.

Your declarations, undertakings and acknowledgments - Exclusion of our liability

1. By making the application as Student, you declare and undertake:

- to be in possession of the eligibility requirements set out in the Call for students;
- that the information provided during the application process and the entire performing of the Project is complete, true and accurate;
- to understand that any mis-statement renders you liable to disqualification from the Project and will preclude a priori participation to any other mobility project managed by us over the years to come.

2. By making the application as Student and for the entire period of your participation to the Project, you expressly agree:

- to comply with all commitments set out in these Terms and the Call for Students;
- to comply with all commitments undertaken with the Host Organization, including those provided in the "[Letter of Availability](#)" and the "[Learning Agreement](#)";
- to sign the "Letter of Availability" for only one Host Organization;

- to comply with the procedures and times set out for the Matching Phase between you and the Host Organization as set out in the [Guidelines](#) to the use of the Platform.

3. By making the application as Student, you acknowledge and undertake that:

- EuGen is not liable for events that may affect your registration to the **Portal**, your application as Student and the Matching Phase between you and the Host Organization, including, for instance, in case of malfunction of the servers of the **Portal**, activities carried out by the Host Organization and force majeure events;
- EuGen is not involved in the management and/or organization of the internship activities and, thus it is not liable for any events that may affect the course and / or the way the internship with Host Organization is conducted;
- the Host Organization is the only subject liable for the proper management of the internship activities in relation to the Project;
- the Host Organization is the only subject liable for the information provided and the activities carried out by the latter in relation to the Project and, thus, EuGen is not liable for the information provided by Host Organization and/or for any behaviour carried out by the latter in relation to the internship activities;
- you are the only subject liable for the information provided and the activities carried out in relation to the Project and, thus, EuGen is not liable for the information provided by you and/or for any behaviour carried out by you in relation to the internship activities;
- EuGen does not approve that Host Organization offers services (including, but not limited to accommodation, training, etc.) to students in return of payment;
- EuGen shall process your personal data for carrying out the Project's activities and Google's indexing may allow displaying students' CVs from Google Search and the time for removal from search results at the end of the Project depends on Google and not on EuGen.

In any case, the aforementioned exclusion and limitation of liability shall not apply in the event damages are caused by our fraud and gross negligence. In addition, some jurisdictions do not allow the disclaimer of warranties or exclusion of damages, so such disclaimers and exclusions may not apply to you and you may have rights in addition to those contained in these terms, especially in relation to consumer rights.

Your exclusion from the Project

Even though you have been considered as eligible for Project, we reserve the right to exclude you from the **Portal** at any time:

- with a 15-day prior notice without cause;

- immediately, if we believe that you have lost your requirements for the eligibility as Student and/or;
- immediately, if you breach any of your obligations set out in the Call for Student and/or in the Project and/or in the following sections of these Terms: paragraphs 1 and 2 of section "Your declarations, undertakings and acknowledgments - Exclusion of our liability", section "Intellectual property rights", section "Confidentiality".

Indemnification

You expressly agree to indemnify and hold EuGen harmless from any claims brought by Host Organizations and/or third parties against EuGen and from any damages suffered by the latter as a consequence of your application as Student and/or your participation to the Project.

Intellectual property rights

We are the owner or the licensee of all intellectual property rights in our **Portal** (including without limitation trademarks and copyrights), and in the material published on it, including without limitation works, images, pictures, dialogues, videos, documents, drawings, figures, logos, menus, web pages, graphics, colours, schemes, tools, fonts, designs, diagrams, layouts, methods, processes, functions and software. Copyright, trademark and other intellectual property laws and treaties around the world protect those materials. All such rights are reserved.

You may not print off, download extracts of or copy any content from our **Portal**. You are aware that your personal data will be visible to the Host Organizations registered in the EU4EU Portal, for the purposes of the Erasmus + Program as well as for the scholarship.

Photo/Video release form

You are aware that during my mobility you might be required to provide a photo or a video as testimonial of the project EU4EU for promotional purposes. If this possibility occurs:

1. You grant EuGen and its designees the right to use the photo/audio-visual in any format. You grant the right to edit, mix or duplicate and use or re-use the photo/audio-visuals in whole or in parts as EuGen may elect. EuGen or its designees have complete ownership of the photo/audio-visuals, including copyright interests.

To the fullest extent permitted by applicable law, we disclaim all liability arising from any reliance placed on such content by any user of our Platform, or by anyone who may be informed of any of its content.

Applicable law and jurisdiction

These Terms are governed and construed in accordance with the laws of Italy. If you reside in the EU, please note that the mandatory consumer protection provisions of the law of the Member State in which you reside will also apply. You have the right to bring
